SECTION 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: Foam, carbon dioxide Extinguishing media which must not be used for safety reasons: Full water jet

5.2 Special hazards arising from the substance or mixture

Extremely flammable aerosol. Pressurised container: May burst if heated.
